- E. Use of this unit is for a single-family residence only. No corporation, company, partnership, or trust may lease an apartment.
- F. No commercial vehicles, trucks, boats, trailers, motor homes, mobile homes, campers, recreational vehicles, motorcycles, mopeds, etc. are permitted to park on the premises overnight. Only one (1) assigned parking space is available per unit.
- G. The current owner must provide the lessee with a copy of the Rules and Regulations.
- H. Occupancy regulations: two-bedroom apartment no more than 4 occupants.
- I. Hours for moving must be arranged in advance with the management.
- J. A copy of the lease agreement must be attached to this application.
